**307/15 CONSIDERATION AND RESOLUTION TO AGREE THAT RESIDENTS SHOULD BE ASKED A QUESTION IN THE COUNCIL'S SPRING NEWSLETTER, VIA SOCIAL MEDIA AND VIA THE NOTICEBOARDS REGARDING THE PROPOSED HIGH DEPENDENCY CAREHOME IN THE NEIGHBOURHOOD PLAN**

The chair introduced the agenda item and invited each parish Cllr in turn to give a 3 minute presentation on his views on the agenda item. Cllrs Worboys, Harris, Stewart, Fellows, Bell, Fleming, David and Faulkner made presentations. Cllr Robinson-Giannasi did not wish to speak. The chair summarised the agenda item and after debate in which the Neighbourhood Plan Steering Group clarified the definition of the carehome included in the draft Neighbourhood Plan, the chair asked the council whether to defer a decision or continue with a vote on the resolution. The council voted with a vote of 6 votes for deferral and 4 votes against, to defer a decision pending further input from the NPSG.
